- Meeting Minutes:
 - Members in attendance: 22 in attendance and we received 12 proxys on file. We have a quorum.

o Jan - Landscaping

#1 Landscaping mulched all common areas and applied river rock, removed dead shrubs, removed 7 trees behind condos, removed shavings from trees, put down new topsoil.

This is the first year for #1 Landscaping to do weeding. Did a better job than prior contractor, but Dan indicated we have weeds that spread that they missed. Doug requested anyone who has weeds to let the Board know. Anything from garage back is our responsibility. If you want #1 Landscaping to do any work let Jan know.

o Structures -

Would like to have more people on committee. Please complete any interest on the form that was distributed. This will not be a big time commitment. Structures is in charge of reviewing plans that are submitted for changes outside the home. Plans are submitted to the board for final approval. We try to turn it around in a week.

Fencing is requested on Trails Edge by Costco. A separate meeting will be scheduled for that.

The Structures Committee will also be involved in the upcoming siding project.

Some concrete driveways and sidewalks are becoming a safety hazard. If it is happening at your home, it is your responsibility and should be repaired.

Each homeowner must submit certificate proving their home is covered for the full value of the replacement. These certificates should be mailed to the association or dropped off with Mae.

- Past newsletters and meeting minutes
- Siding update
 - Doug announced that he has been able to engage the Cleveland Urban Design Collaborative to assist with our siding project. We will be working with one of the graduate architectural students to help with design suggestions, material sections, and construction specifications.
 - Starting next year homeowners will have the choice of (a) residing (b) staying with the existing T-111 wood siding. Colors for either choice will be finalized with the assistance of CUDC, and homeowners will have their choice of 3-4 colors.

- In 2024, any homes who do not decide to install vinyl siding will be stained. Our current painting fund should have enough to restain your home green one more time.
- We will be conducting a "Contractors Day" in mid-January 2022 to discuss the project with selected contractors. Bids will be due by the end of January. We should be able to report back to homeowners by early February with more exact costs.
- Sample siding colors were available for review and voting.
- Doug asked for any feedback or questions from attendees:
 - We will look into new mailboxes. Structures committee will investigate.
 - If siding is done is 2022, funds will no longer be required in the painting fund, and you pay about \$50 less per month.
 - Retaining wall: no plans to update, property is for sale and we don't want to put the money into repairing if avoidable. Will look at cosmetic changes.
